ENVIRONMENTAL POLICY

The management of ASSUT EUROPE SpA is fully aware of the challenges and opportunities that the market imposes and of the need to make choices in line with the principles of sustainable development.

The Management of ASSUT EUROPE SpA also recognizes that pursuing a policy of continuous improvement of its environmental performance which minimizes, where technically possible and economically sustainable, any negative impact of its activities on the environment, leads to significant commercial and economic advantages, satisfying, at the same time, the expectations of environmental improvement relating to the context in which the Company operates.

Therefore, the Management of ASSUT EUROPE SpA considers it of fundamental importance to implement and maintain an Environmental Management System, compliant with the requirements of the UNI EN ISO 14001: 2015 standard, which not only guarantees compliance with legislation and environmental requirements, but which allows to obtain a continuous improvement of the environmental performance of its activities, products and services in their entire life cycle (identification of company risks / opportunities), eliminating and mitigating risks for the environment at the same time.

The Management of ASSUT EUROPE SpA intends to reach this goal through the following actions:

- 1. analyzing, from a perspective of the product life cycle, the context in which the organization operates and the interested parties
- 2. carrying out an in-depth analysis of the environmental aspects / impacts that may derive from the activities directly or indirectly managed by your organization, present and operating in the manufacturing plant in Magliano dei Marsi
- 3. ensuring cooperation with all interested parties
- 4. knowing, promoting and controlling the environmental management of our suppliers
- 5. Promoting the responsibility of employees at all levels to protect the environment and orient the corporate culture towards environmentally friendly behavior
- 6. assessing in advance the environmental impacts of new production processes and / or modifications of existing facilities
- 7. adopting the necessary measures to reduce the environmental impacts associated with emergency situations and potential pollution, and implementing information and training programs for personnel
- 8. protecting air, water, soil and subsoil through suitable and careful management of waste produced within the facility
- 9. monitoring and minimizing the consumption of resources (energy)
- 10. monitoring and containing the production of waste, promoting its recovery where possible
- 11. promoting and ensuring the correct disposal of end-of-life products providing customers and consumers with the necessary information on the environmental impacts of the products marketed

- ensure that the environmental policy set out here is communicated to workers with posting on company premises, and to interested parties with the help of the Web.

The Environmental Management System Policy is also based on general concepts such as the widespread commitment of the Management, the allocation of suitable resources, the promotion of continuous improvement and the effectiveness / efficiency of the Environmental Management System.
