

Car Fleet Emissions

Target Completion Date: 31/12/2027

Objective

To reduce the average overall C02 emissions of the company car fleet

Target

To reduce the carbon emissions of the company car fleet 30% by 2027

Action, Improvement or Control

Any new fleet vehicle leased to have emissions no greater than 115g/km (eg 95g/km) Purchase electric cars and Install electric car charging stations Educate employees on maintenance of their vehicles and raise awareness on fuel effciency

Electricity - Lighting and general use

Target Completion Date: 31/12/2025

Objective

To work with Landlord on any possible improvements to reduce CO2 emissions for the office in relation to lighting and general use.

Target

To monitor CO2 emissions and ensure there is no increase in the amount of energy used by the organisation in relation to lighting and general office use.

Action, Improvement or Control

Posters reminding to turn off lights, computers and other electrical items up in office. Ask landlord about putting Timers on lights in bathrooms and other appropriate spaces, to install motion sensors for lighting in hallways and other appropriate areas and to change all lighting to energy saving alternatives Replace high energy rated appliances with lower energy rated versions

Product Packaging

Target Completion Date: 31/12/2023

Objective

To reduce the amount of product packaging going to landfill

Target

90% of packaging purchased to be made from recycled materials and responsibly sourced in 2023 90% of packaging coming into warehouse to be reused or recycled in 2023

Action, Improvement or Control

Only purchase recycled packaging Reuse all packaging that comes into the office.

Transportation - Receiving and delivery of goods

Target Completion Date: 31/12/2025

Use the lowest impact transport method available

Target

Reduction of c02 emissions by 15% by 2025

To request environmental policies from delivery companies used. Encourage and incentivise customers to bulk buy and order efficiently Change to lower emissions transportation options eg couriers who use electric vehicles, use shipping not air freight
